NOTICE IS HEREBY GIVEN that the City Council of the City of La Habra will hold a Public Hearing to review and approve a substantial amendment to the FY 2019-2020 and FY Annual Action Plan. The substantial amendment will cancel the following programs:

1. (FY 19-20) Code Enforcement \$65,105.00
2. (FY 19-20) VCC-Vista Community Clinic Application Assistance \$4,142.00
3. (FY 19-20) Portola Park Parking Lot \$55,917.00
4. (FY 19-20) Community Services-Youth Sports Grants \$4,603.00
5. (FY 19-20) Community Services-Senior Health and Wellness \$2,762.00

The total amount of CDBG funds from canceled programs is \$132,529.00. Staff is recommending City Council cancel the above programs and approve increasing funding amounts to the following already approved FY 19-20 programs:

1. (FY 19-20) Loma Verde Parking Lot increase from \$ 8,191.00 to \$ 42,291.00
2. (FY 19-20) Alley Improvement Program increase from \$92,706.00 to \$114,523.00

The balance in the amount of \$76,612.00 from the above mentioned canceled programs will be carryover funds for FY 20-21.

1. (año fiscal 19-20) Aplicación del Código \$65,105.00
2. (año fiscal 19-20) VCC: Vista Community Clinic \$4,142.00
3. (año fiscal 19-20) Estacionamiento en el parque de Portola \$ 55,917.00
4. (año fiscal 19-20) Los servicios de los jóvenes de la Comunidad Deportes Subvenciones \$ 4,603.00
5. (año fiscal 19-20) Servicios comunitarios-Salud y bienestar para personas mayores \$ 2,762.00

La cantidad total de los fondos de CDBG de los programas cancelados será \$132,529.00. The Substantial Amendment proposes to cancel the following programs:

Staff is proposing canceling funding Code Enforcement due to reporting requirements from U.S. Department of Housing and Urban Development (HUD).

VCC- Vista Community Clinic Application Assistance is proposed to be canceled because the award amount was not sufficient enough to hire the requested staff and comply with all of the administrative requirements of CDBG funding, therefore staff is recommending canceling the program.

Portola Park Parking Lot program is proposed to be canceled because it will be completed at a later date, therefore staff is recommending canceling the program.

Community Services-Youth Sports Grants and Senior Health and Wellness programs are proposed to be canceled due to the reporting requirements from (HUD), therefore staff is recommending canceling the programs.

- *PROPOSED INCREASED FUNDING TO CURRENT FY 2019-2020 PROGRAMS*

A total of \$132,529 is available to reallocate from the combined proposed canceled programs. With the available funds, staff is proposing to increase funding to two already approved CDBG eligible programs for FY 2019-2020 as follows:

The total amount of available CDBG funds from proposed canceled programs is \$132,529. The proposed Substantial Amendment would allocate a total of \$55,917 to two Public Facilities & Improvement Programs. The balance in the amount of \$76,612 will be carryover funds for FY 2020-2021.
